§1 SYNCHRONICITY WORKSHOP Details

1.1 The Contract Partner is hosting a dance workshop from 23.01.26 to 25.01.26.

Location: COLOGNE (TBA)

1.2 The intensive includes various dance styles (e.g., jazz, commercial, musical, etc.), technique classes, movement awareness, body language, movement quality, performance training, energy management, stage and camera work, artist interaction, industry talks, and injury prevention. All classes are led by multiple professional and highly qualified creatives, choreographers, and coaches selected by the Contract Partner.

§2 Payment

2.1 CONDITIONS

The fee for the SYNCHRONICITY COLOGNE 2026 is:

- 3 DAY PASS: 349 EUR
- 2 DAY PASS: 299 EUR
- 1 DAY PASS: 165 EUR

All prices include VAT (MwSt).

2.2 DISCOUNTS

Early Bird discounts, collaborator discounts, and other special offers may be provided at the sole discretion of the Contract Partner.

The Contract Partner reserves the right to create, modify, or discontinue such discounts at any time without prior notice.

Any discounted rates granted remain valid only under the specific conditions under which they were offered.

§3 Intensive Logistics

3.1 The Contract Partner ensures the availability of the workshop location as stated in §1.1.

3.2 The Dancer is responsible for wearing appropriate clothing and shoes throughout the entire duration of the intensive and for bringing necessary materials such as a pen and notebook.

3.3 Any specific props required for the SYNCHRONICITY Workshop will be provided by the Contract Partner.

3.4 The Dancer is responsible for providing their own food and beverages during the event.

§4 Liability

4.1 The Contract Partner assumes no responsibility for any injuries or damages sustained by the Dancer. The Dancer is advised to have appropriate personal insurance.

4.2 The Dancer is responsible for their personal belongings. The Contract Partner will not be liable for the loss of any valuables.

§5 Contract Partner's Right of Cancellation

The Contract Partner reserves the right to cancel the workshop at any time due to unforeseen circumstances, including but not limited to illness, logistical complications, or force majeure. In such cases, each Dancer will be notified immediately. All payments already made will be fully refunded. No further claims beyond the refund of the workshop fee can be made.

§6 Cancellation and Refund Policy

6.1 The Dancer may terminate this agreement in case of illness or injury by submitting a valid medical certificate. In such a case, the Dancer will receive a voucher for other RME of LOVE events.

6.2 If the Dancer cancels the agreement for any other reason or without a medical certificate, no refund will be issued.

§7 Confidentiality

7.1 The Dancer agrees not to disclose the contents or conditions of this contract to third parties. This obligation remains in effect even after termination of this agreement.

7.2 By clicking the “BUY” button, the Dancer confirms that they have read and fully agree to the terms of this agreement.

§8 Consent to Recording and Rights Transfer

8.1 The Dancer expressly agrees that photo, audio, and video recordings may be made during the workshop in which they may be recognizable.

8.2 The Dancer grants the Contract Partner, free of charge and without any limitation in time, location, or scope, all rights to use, reproduce, distribute, publicly display, and edit any recordings of their person made during the workshop. This includes, in particular, use for promotional purposes, on social media, websites, in print media, trailers, or other audiovisual formats.

8.3 The Dancer may not request removal or blocking of individual content after the fact, unless legal grounds exist (e.g., violation of personal rights).

§9 Changes to Line-Up

9.1 The Contract Partner reserves the right to make changes to the schedule, class content, and line-up of instructors if necessary.

9.2 While the Contract Partner aims to deliver the program as advertised, the participation of specific teachers cannot be

guaranteed. No claims for refunds or compensation will be accepted due to such changes.
